2. The estimate is only a guide as to the price each lot is expected to realise. Bids may be higher or lower than the estimate. Some consignors give us their reserve prices, but other consignors don't put reserve prices on their lots.
3. All bids must be in multiples of £1.
4. The highest bidder shall be the buyer of each lot. Lots will be sold at the lowest price allowed by other bidding, bearing in mind the reserve (if any) set by the seller.
5. In the event of identical bids, the first received shall take preference.
6. In the event of a dispute, a lot may be offered for resale.
7. The seller will be charged 10% of the hammer price and the buyer 10%, such proceeds will be retained by the Society.
8. Items dispatched by post will be at the risk of the buyer/seller to whom they are addressed, and the postage will be charged by the Society.
